Re: COSAM's Support for SB24-022, Bill to Regulate Flavored Tobacco Products

Dear Senator Exum:

On behalf of the Colorado Society of Addiction Medicine (COSAM), the medical specialty society representing physicians and clinicians in Colorado specializing in the prevention and treatment of addiction, we write today in support of SB24-022. This important legislation would allow county commissioners enhanced authority to regulate nicotine and tobacco products. Specifically, SB24-022 would allow county officials to prohibit the distribution of flavored nicotine and tobacco products, aligning with recommendations from the American Society of Addiction Medicine (ASAM)'s policy statement on e-cigarettes. ¹

Simply put, we believe that flavored tobacco products pose a significant risk to the public, specifically to young people who are major consumers of these products. The enactment of SB24-022 could abate use. Although traditional cigarette smoking continues to decrease among American teens, use of flavored electronic cigarettes remains a major concern. According to 2023 national estimates, e-cigarettes were the most used tobacco product among middle and high school aged students.² Further, an estimated 16% of high school students in Colorado use electronic cigarettes, higher than the national average. Nationally, nearly 90% of the students who use electronic cigarettes report consuming flavored products.³ The long-term effects of this early usage are unknown.

There is a risk that electronic cigarette use will lead to subsequent combustible tobacco and other drug use. While tobacco use has decreased in the general population, prevalence is higher in minority groups, including those with low socioeconomic status and mental health disorders. Tobacco threatens our patients in particular; as tobacco-related illness is the leading cause of death among persons with substance use disorders.⁴

COSAM strongly supports SB24-022 and is grateful to the bill sponsors. This bill aims to

reduce harmful tobacco use while also respecting the key role of local elected officials. Please do not hesitate to contact me if there is any other assistance that we can provide.

Re: COSAM's Support SB24-047, Prevention of Substance Use Disorders

Dear Senator Fields:

On behalf of the Colorado Society of Addiction Medicine (COSAM), the medical specialty society representing physicians and clinicians in Colorado specializing in the prevention and treatment of addiction, we write today in support of SB24-047. This expansive legislation contains provisions to address various prevention efforts for substance-use disorder (SUD) in our state. Specifically, SB24-047 would dedicate more resources to communities of the highest need and invest in the implementation of substance use screening, brief intervention, and referral to treatment (SBIRT) system statewide. Further, it would allow for the collection of more data on the prevalence of SUD and overdose fatalities.

Each year, thousands of Coloradans tragically lose their lives to overdose. A key part of a wholistic approach to combat the overdose crisis is a significant investment in the prevention of SUD. As the American Society of Addiction Medicine (ASAM) notes in its policy statement on prevention, effective prevention measures can reduce serious injury and death associated with substance use, misuse, and SUD and improve quality of life. Further, evidence-based prevention measures can increase productivity and potentially save taxpayers money. Simply put, pursuing effective prevention measures is a sound financial investment that saves lives.

As one important prevention investment, among many, we would like to highlight SB24-047's proposed expansion of SBIRT on a statewide basis. SBIRT is a recommended practice by the U.S. Preventive Services Task Force (USPSTF).⁴ Specifically, the expanded adoption SBIRT in primary care can prove essential to retain patients and continue to provide services. Ultimately, proper investments in SBIRT up front can save costs associated with substance misuse/SUD in the future. As such, its proposed expansion is a worthy step and one that could prove highly beneficial for Coloradans.

On the whole, SB24-047 takes significant steps towards properly investing in a range of impactful prevention measures for SUD. As such, COSAM strongly supports SB24-047 and urges for its continued advancement. Thank you for the opportunity to provide comments.
