Re: MISAM's Support for HB 4707

Dear Representative Carter,

On behalf of the Michigan Society of Addiction Medicine (MISAM), the medical specialty society representing physicians and clinicians in Michigan who specialize in the prevention, treatment, and recovery from addiction, thank you for the opportunity to comment on this important topic. We write today to express our support for HB 4707. This legislation would expand access to evidence-based care by requiring that insurance plans cover a full continuum of services for mental health and substance use disorder (SUD), without prior authorization. Additionally, HB 4707 would adopt a consistent definition for medically necessary mental health and SUD services using the appropriate the level of care placement criteria and practice guidelines set forth in the most recent versions of utilization review criteria and practice guidelines developed by nonprofit professional associations for the relevant clinical specialty. We believe that this important legislation will benefit patients in our state by expanding and ensuring access to quality care for SUD.

Currently, far too few people with SUD receive the treatment services that they need. According to the Substance Abuse and Mental Health Services Administration (SAMHSA), 46.3 million people aged 12 or older met the DSM-5 criteria for having a substance use disorder. However, 94% of this same group did not receive any treatment in 2021. In light of this data, lawmakers must take every step possible to remove barriers to accessing potential life-saving treatment. Utilization management policies, such as prior authorization, serve as a significant barrier to care for many patients. Further, restrictive utilization management policies also impact health outcomes, iii causing disruptions and delays in care for those already in treatment.

HB 4707 precludes prior authorization if treatment services are determined to be medically necessary according to the appropriate the level of care placement criteria and practice guidelines. These criterion and guidelines provide a reliable framework to ensure that coverage decisions are determined by evidence-based standards. These standards will ensure that patients get the right care, in the right place, and at the right time.

MISAM applauds HB 4707 for addressing the appropriate use of medical necessity determinations and the crippling burden of utilization management. We urge members of the committee to recognize the need for greater access to treatment and favorably report HB 4707.
