AMSAODD Board Meeting Highlights

Over 30 physicians attended the Feb. 22, 1987, board meeting in Ft. Lauderdale, FL.

<u>Certification</u>: (Margaret Bean-Bayog, MD) Certificate ceremony for those who passed the 1986 AMSAODD exam, or the California Society 1983 or 1984 exams, at our annual luncheon, Saturday, April 25, Stouffer Inn on the Square, Cleveland, OH.

Executive director E. M. Steindler to explore a relationship between AMSAODD's certification project, and subspecialty certification in association with relevant boards, such as the ABIM, ABPN, ABFP.

Board Meeting (Cont.)

<u>Credentialling Subcommittee</u>:(Marc Galanter, MD) AMSAODD-certified members total 735. Of these, 565 passed the 1986 certification exam; 163 had previously been certified by the California Society; 7 were Exam Subcommittee members who helped to develop the exam.

For those unclear about how to mention their AMSAODD certification on c.v.'s, etc. the subcommittee will prepare precise wording, for Board approval.

Exam Subcommittee: (Tony Radcliffe, MD) 100 did not pass the 1986 exam. Scoring process for the 1986 exam:

--scores on each part (multiple choice question's and patient management problems) were considered separately in order to pass.

--a passing score was 1.2 standard deviations or less from the mean, based on combined pooling of 1983 and 1984 (California Society) and 1986 AMSAODD scores.

AMSAODD to issue a Request for a Proposal (RFP) for the development of the 1989 certification exam; the current California Society contract with AMSAODD ends April 1988.

All data developed thus far from exam process belongs to AMSAODD. Any material generated by AMSAODD is the private property of the society and no individual has the right to use it without prior approval of the Board.

<u>Fellowship Subcommittee</u>: (James Halikas, MD) Interested fellowship directors and AMSAODD members to brainstorm CD (chemical dependency) fellowship problems in Cleveland on Friday, April 24, at 10:00 AM. Dr. Halikas has a list of desirable components for CD fellowship training programs.

<u>New subcommittee</u> (of Certification committee) will develop a core curriculum for various levels of medical education.

Review Course: (Anne Geller, MD)

New Orleans.....Sept. 17-19 (Drs. Donald Gallant, Lynn Hankes) <u>Chicago.....Oct. 8-10</u> (Drs. David Benson, Amin Daghesami) <u>San Francisco...Oct. 22-24</u> (Drs. Garret O'Connor, Sanford Reder, Peter Banys) <u>Washington, DC...Nov. 5-7</u> (Drs. Martin Valaske, Mary Dufour) Working committee in New York to develop a uniform syllabus for Review Course.

<u>Publications</u>: (Stanley E. Gitlow, MD) AMSAODD intends to extend its contract with Williams & Wilkins, publisher of the 'blue journal' (<u>Alcoholism: Clinical & Experimental</u> <u>Research</u>) for one more year, should the Research Society on Alcoholism desire such a continuation. AMSAODD would thus guarantee 300 subscriptions at \$50 each (\$15,000), but would indicate to RSA that this arrangement would end Dec. 1, 1988.

In February, many <u>AMSAODD members received \$70 renewal notices for the blue journal</u> from <u>Williams & Wilkins</u>. This occurred <u>without AMSAODD's knowledge</u>, since all members had the concurrent opportunity to subscribe for \$50 when paying their annual dues. [W & W offering refunds to any AMSAODD member who inadvertently subscribed twice to journal.]

AMSAODD Newsletter now accepts advertisements from treatment centers and drug companies. All drug ads will be reviewed by a committee of physicians, prior to acceptance.

<u>Newsletter</u> now welcomes "pending policy" statements. If chair of a committee sends a draft of AMSAODD policy statement to editor Lucy Robe, Newsletter will explain that committee is still changing and polishing the statement, and that AMSAODD invites members to comment to their area representatives on the AMSAODD board. Send policy statements to <u>Newsletter</u> at any stage of development that committee wishes.

"Future Meetings" free listings in <u>Newsletter</u> restricted to conferences sponsored or co-sponsored by AMSAODD. "New Books" free listings limited to books by AMSAODD members, or authors related to AMSAODD.

No flier enclosures can be inserted in Newsletter at present time.

No official publication, or publication with official sanction, or publication bearing official comment, can use AMSAODD's name without prior approval of the material by the Board, or by an approved committee.

Board Meeting (Cont.)

Medical Education: (James A. Halikas, MD) AMSAODD sponsored or co-sponsored 12 conferences between Jan. 23 and April 26, 1987.

Standards & Economics of Care: (Percy Ryberg, MD) In the APA's revision of DSM-III for DSM-III-R, the term "abuse" (psychoactive substance abuse) is back in the document. AMSAODD board voted to contact APA and request inclusion in process to formulate DSM-IV. Nomenclature committee will be formed.

AIDS & Chemical Dependency: (Larry Siegel, MD) (See report p. 4 on the AIDS Forum.) Board approved a 1988 AIDS conference, chaired again by Dr. Siegel, who welcomes suggestions from AMSAODD members for workshops, topics and speakers.

Committee's "Facility Guidelines for Substance Abusers at Risk for and Infected with Human Immunodeficiency Virus (HIV)" approved by Board.

Budget & Finance: (William B. Hawthorne, MD) Reimbursements for expenses of members participating in AMSAODD programs must be approved in advance by this committee, and the president.

All AMSAODD news releases must be approved in advance by the president or executive director. AMSAODD will hire someone to prepare news releases and handle press contacts.

Public Policy: (Sheila B. Blume, MD) Board approved the following policy: "Recognizing the immense personal, social and economic cost of drug dependencies to society at large, <u>AMSAODD acknowledges that drug dependencies are diseases</u> and are a <u>legitimate part of medical practice</u>. In addition, AMSAODD encourages individual physicians, other health professionals, medical and other health-related organizations, government and other policy-makers to inform themselves about drug dependencies and to base their policies and activities on the recognition of drug dependencies as diseases." AMSAODD policy statement on "Children of Parents Suffering from Alcoholism or Other

Drug Dependencies" also approved by Board.

Confidentiality Subcommittee: (Sheila B. Blume, MD, acting chairperson) has been made part of the Public Policy Committee. AMSAODD members are encouraged to recommend members.

Membership Committee: (LeClair Bissell, MD) Dr. Bissell was asked to recommend proposed reduced dues figures for retired, foreign and other special individuals.

Trauma: (Joseph J. Zuska, MD) AMSAODD's exhibit at the Oct. '86 American College of Surgeons meeting interested nearly 200 physicians.

Report from Executive Director: (E. M. Steindler)

Mr. Steindler hopes to help implement AMSAODD's Long Range Plan, which was approved by the Board in September. Several directors of AMA divisions were not aware of AMSAODD's certification process, but are very interested in it. Important to publicize AMSAODD's policies. Liaison with government agencies essential.

He is exploring areas that would benefit AMSAODD members beyond reduced journal subscriptions, bi-monthly Newsletter, chance for certification, reduced meeting fees.

Other: According to Dr. Chen See, some foreign members with frozen monies may have a problem paying AMSAODD dues. Any member of AMSAODD who wants to help a foreign colleague, please contact Claire Osman in the New York office.

AMSAODD will create a <u>new ad hoc committee</u> to study <u>methadone maintenance</u>. Chair: James T. Payte, MD.

Board approved AMSAODD statement that diagnosis of alcoholism should not preclude consideration of liver transplant as treatment mode. AMSAODD also opposes arbitrary abstinence length as a requirement before alcoholics can be considered for organ transplantation, but recommends decisions on a case by case basis. AMSAODD joining NCA (National Council on Alcoholism) in supporting amicus brief in a Michigan case. Next Board meetings: April 22, and 25 (new officers) in Cleveland OH.

AIDS & Chemical Dependency

About 150 participated in the AMSAODD-sponsored conference on AIDS & CD in Ft. Lauderdale FL, Feb. 20-21. Forum explored the relationship between drug and alcohol use and AIDS; how to treat chemically dependent patients who have--or risk developing--AIDS, or ARC (AIDS-related complex), or HIV (human immunodeficiency virus, also known as HTLV/LAV infection); and how to educate patients and staff about AIDS.

Chemical dependency apparently heightens risk of infection and subsequent illness, through a greater tendency to risk-taking (particularly sexual and sharing needles), and immunosuppression by alcohol and other drugs. "Many drugs of abuse predispose to risky behavior--including sexual," according to Larry Siegel', MD, of Key West, chairman of the AIDS Forum. He believes that effective intervention in drug and alcohol misuse may offer a practical means to help curtail the AIDS epidemic.

"It is absolutely critical for chemical dependents to be well informed about AIDS," declared David E. Smith, MD, of the Haight Ashbury Free Medical Clinic in San Francisco. Theories suggest that "infection with HIV alone is not sufficient to cause the development of AIDS." Co-factors may damage the immune system along with HIV. The drugs most commonly suspected are: "alcohol, marijuana, cocaine, amyl and butyl nitrate, and perhaps opiates and PCP."

Luncheon speaker Robert G. Niven, MD, former director of the NIAAA, and others deliberated over whether physicians should treat the chemical dependency of PWAs (persons with AIDS) who are expected to die soon.

Several physicians described how change in lifestyle can be beneficial through:

- --better general health to fight infection;
- --some recovery of immune impairment in some patients;
- --discontinued exposure to HIV (particularly if sexual lifestyle changes and use of contaminated needles stops).

With these changes, seropositives (those with HIV) might not necessarily develop AIDS. Those with AIDS would have an improved quality of life in the time left to them.

Another major issue was whether a CD facility should treat AIDS victims, or, indeed, should even test for it, particularly in risk groups such as IV users and gay men. "The idea of an onslaught of AIDS patients scares chemical dependency treatment centers," said William B. Hawthorne, MD, of New England's Mediplex Group. "Professionals fear that staff as well as patients will panic if their facility treats patients who have AIDS. Most are unclear about what to do." Dr. Hawthorne believes that "education and knowledge can replace the current hy'steria," and that families as well as patients and staff should be educated.

Dr. Hawthorne also said that an "informal survey" he conducted indicated that most rehabs have seen few AIDS/CD patients. "In fact, most said that they have had only one, if that. So we have breathing time before any onslaught."

Letters to Editor

Dear Editor:

Questions have been raised in the <u>AMSAODD Newsletter</u> regarding the ethics and legality of reporting cases of suspected child abuse to state hotlines when patients are covered by federal confidentiality laws and regulations covering alcohol and drug treatment. The August 1986 U.S. Public Law 99-401 resolves the former conflict between federal confidentiality regulations and state mandated child abuse reporting. The new law adds the following language to the federal confidentiality law:

"The prohibitions of this section do not apply to the reporting under State Law of incidents of suspected child abuse and neglect to the appropriate State or local authorities."

Note that only the <u>initial report of</u> <u>the incident</u> can be made without consent. Any requests for additional information and the patient's record itself are still protected. A signed informed consent or specific court order issued under subpart E of the regulations are required, subject to all of the restrictions of the regulations, as in any other request for information.

Dear Editor:

The letter in the January 1987 Newsletter from James M. Todd is an eloquent testimonial in favor of increasing the training requirement for board certification.

Dr. Todd might be interested to learn that the "controversial" and "illegal" technique of management with methadone maintenance is currently being used to treat about 75,000 patients per year. As a physician who has been involved in methadone treatment for over 10 years, I am concerned that so many "Addictionologists" think that methadone maintenance is an unimportant or unsophistocated method of treating narcotic dependence.

Methadone maintenance is strictly regulated by State and Federal governments and is extremely cost-effective, particularly in comparison with inpatient programs, which, for the most part, are limited to the very wealthy or the very insured. In spite of the frequent claims by specific drug treatment programs or practitioners pushing specific treatment modalities, there is no evidence what so ever that any method of treatment is any more effective than methadone.

If AMSAODD placed heavy emphasis on methadone maintenance in the 1986 board, I would like to congratulate the authors for their perspective on drug treatment in the real world.
