

#### ASAM's State of the Art Course Set for October 25th-27th

A SAM's 2007 Course on the State of the Art in Addiction Medicine, which focuses on cutting-edge developments in addiction research and their implications for clinical practice, will meet October 25th-27th at the Hyatt Regency Capitol Hill Hotel in Washington, DC.

Course Chair Markus Heilig, M.D., Ph.D., working with Co-Chairs Lawrence S. Brown, Jr., M.D., M.P.H., FASAM, Edwin A. Salsitz, M.D., FASAM, and Stephen A. Wyatt, D.O., have designed the course to meet the needs of multiple audiences: (1) addiction specialists who seek an update on recent developments in addiction research and practice; (2) individuals who conduct or wish to obtain funding for addiction research; (3) educators who are concerned with translating scientific knowledge to clinical services, and (4) physicians, nurses, counselors and other professionals who seek a succinct review of the latest knowledge about the causes, identification, and management of addictive disorders.

The State of the Art Course is accompanied by a Buprenorphine Training Course, to be offered on Sunday, October 28th at the same hotel. ## **Buprenorphine Course Offers Up to 8 CME Credits**

A SAM's course on "Buprenorphine and Office-Based Treatment of Opioid Dependence" will be offered in conjunction with the State of the Art Course, on Sunday, October 28th. Like the State of the Art Course, the Buprenorphine Training Course will be held at the Hyatt Regency Capitol Hill Hotel in Washington, DC. Topics to be addressed by an expert faculty include:

- The rationale for, efficacy and safety of buprenorphine treatment of opiate addiction..
- Provisions of the Drug Addiction Treatment Act of 2000 (DATA 2000) and recent amendments, which provide the legal basis for the treatment of opiate addiction in office-based settings.

- Selecting and assessing patients who are appropriate candidates for treatment with buprenorphine.
- Induction, stabilization and maintenance protocols for the use of buprenorphine.
- Combining non-pharmacologic therapies with buprenorphine.
- Use of clinical tools (such as treatment contacts, consent forms and protocols) in office-base treatment with buprenorphine.
- Common medical and psychiatric comorbidities found in opiate-addicted patients, including HIV/AIDS, hepatitis B and C, depression and anxiety. continued on page 2



re you coming to Washi-Angton, DC, in October to attend ASAM's State of the Art Course? If so, please make time to meet with your Congressional delegation. Mental health and addiction policies are hot topics on Capitol Hill these days, and Congress needs to hear from you!

For example, Dr. Ken Roy, who chairs ASAM's Parity Action Group, points out that there are bills in both the U.S. House and Senate that address parity for mental



So please take advantage of the Hyatt Regency Hotel's proximity to the Hill and ASAM's government relations staff by scheduling a short visit with your state's Representatives or Senators. ASAM's staff will arrange the visits for you. They also will provide a teleconference advocacy training session the week before you



arrive in Washington. The training will include an overview of timely issues and legislation, talking points for your meetings, and general grassroots advocacy tips and techniques.

#### Are You New to **Grassroots Advocacy?**

If you've never met with a member of Congress or otherwise advocated for a cause, it can seem like an intimidating endeavor. ASAM's government relations staff can help you, whether this visit is your

first or your 50th. For example, ASAM hosts an advocacy website at WWW.ASAM.ORG, where you'll find:

- ★ Information about ASAM advocacy events
- ★ Updates on current federal and state legislation of interest
- ★ An advocacy toolkit complete with: an advocacy tutorial, instructions on how to contact Congress and what to say, a glossary of advocacy terms (what does "mark-up mean, what happens when a bill is "hot-lined," etc), and relevant support materials and reports.
- ★ The latest edition of ASAM's Advocacy e-newsletter
- ★ ASAM public policy statements.

- Management of pain in patients with addictive disorders and the management of adolescents and pregnant women who are addicted to opiates.
- Confidentiality and record keeping requirements for treating opiate-addicted patients in office-based settings.

The course is approved for up to 8 credit hours of Category 1 continuing education credit. (Only those who attend the full 8-hour program are eligible for a certificate of attendance.) A separate registration fee is required. Attendance is limited, so be sure to register early! **GOAL AND ORGANIZATION:** The goal of ASAM's 2007 State of the Art Course is to present the most up-to-date information on the science of addiction and the practice of addiction medicine. To attain this goal, program sessions will focus on the latest research into the causes, prevention and treatment of addictive disorders, and will translate the research findings into clinically useful knowledge. The course also provides an opportunity for participants to interact with outstanding experts from the U.S. and abroad.

The seven sessions of the course are organized around specific areas of new scientific knowledge. Within each session, an expert faculty will provide concentrated reviews of recent scientific advances. In the discussion period that concludes each session, audience and faculty jointly consider how to synthesize the research findings to improve clinical practice and patient care.

#### **TOPICS TO BE ADDRESSED INCLUDE:**

Session 1. What is Addiction? Our evolving understanding of addiction: Plasticity underlying brain reward systems. Recruitment of anti-reward systems in the dependent state. Impulsivity versus self-controlled decision-making.

Session 2. Experimental Paradigms and Individual Predictors of Outcome: The role of family history in response to naltrexone, as demonstrated in an experimental laboratory paradigm. The contribution of genetic mu-opioid receptor variation in alcohol craving. Experimental craving as a predictor of relapse in cocaine addiction. Treatment response as a function of pharmacogenetics.

Session 3. The Role of Pharmacology in Smoking Cessation: The pharmacogenetics of bupropion, varenicline and rimonabant. Combining nortryptiline and behavioral therapy.

Session 4. New Pharmacotherapies for Alcohol Dependence: Naltrexone and acamprosate. Topiramate and CRH-antagonism. Lessons from Project COMBINE and the German Project PREDICT.



Session 5. Pharmacotherapies for Opiate Addiction — Heroin and Prescription Drugs: The epidemiology of opiate abuse and addiction — making sense of the data. Optimal use of methadone and buprenorphine, alone and in combination. Primary care-based treatment of opiate dependence. Buprenorphine-facilitated psychosocial treatment for opioid-abusing adolescents and young adults. Opioid analgesics and pain in the treatment of opiate addiction.

Session 6. Managing Medical Comorbidities: Drug-drug interactions. HIV and buprenorphine. Update on hepatitis C. Therapeutic monitoring as an important element of treatment.

Session 7. Implementing Science-Based Treatments — Obstacles and Opportunities: Evidence-based medicine in the addictions, and addressing the evidence gap. Progress in obtaining reimbursement for addiction care and the impact of coding changes. Removing UPPL laws as barriers to patient care.

WHO SHOULD ATTEND? ASAM's 2007 State of the Art Course is designed specifically for the physician or other professional who seeks an advanced level of understanding of the scientific underpinnings of addiction practice.

**LEARNING OBJECTIVES:** At the conclusion of the State of the Art Course, participants should be able to:

- Understand the current evidence for clinical approaches to treatment in various settings.
- Explore the special issues to be addressed in treating individuals in specific populations or with special physical and mental disorders.

### HOTEL AND TRAVEL INFORMATION



HOTEL: The State of the Art Course will be held at the Hyatt Regency Capitol Hill Hotel, 400 New Jersey Avenue, NW, Washington, DC 20001 (phone 202/737-1234; fax 202/737-5773). A limited number of rooms are being held at the conference rate of \$192 single or double (rates are subject to local taxes). Reservations should be made no later than Thursday, September 27, 2007. TRAVEL FROM LOCAL AIRPORTS: From/to Ronald Reagan National Airport: Taxis are available outside the baggage claim area. The fare is approximately \$14-\$18 (10-20 minutes). One-way fare on the Super Shuttle is approximately \$13. Reservations may be made by calling 800-BlueVan (1-800/258-3826) or online at www.supershuttle.com.

From/to Dulles International Airport: Taxis are available on the lower level of the terminal, outside baggage claim. Taxi fare is approximately \$60 to \$80 (50-60 minutes). One-way fare on the Super Shuttle is approximately \$26.

From/to Baltimore/Washington (BWI) Airport: Taxis are available on the lower level of the terminal, outside baggage claim. The one-way fare is approximately \$63 (60 minutes). The MARC train offers weekday commuter service from the BWI station to Union Station, which is within 3 blocks of the hotel. The MARC fare is approximately \$7 one way.

AMTRAK, MARC, AND METRO: MARC commuter trains run from Baltimore's BWI station to Union Station (weekdays only). For those traveling by local transit (Metro), use the Red Line and exit at the Union Station stop.

Union Station is within 3 blocks of the hotel. Follow the exit signs to the front of Union Station. Take E Street (between the semi-circle of flags) to the intersection of E Street, NW and New Jersey Avenue, NW. The hotel will be directly in front

Taxis are available at the main entrance to Union Station. The fare to the hotel is approximately \$5.50, with rush-hour surcharges possible.

#### **DRIVING DIRECTIONS:**

From Points North: Take I-95 South to exit 22B (Baltimore-Washington Parkway South). Exit onto Route 50 West toward Washington, then exit onto New York Avenue. Stay on New York Avenue for approximately four miles. Make a left onto North Capital Street, proceed for approximately one mile. Make a right turn onto E Street and proceed for one block. Make a left turn onto New Jersey Avenue. The hotel is on the right.

From Points South: Take I-95 North to I-395 toward Washington. As you pass over the Potomac River, stay in one of the middle lanes. At the end of the bridge, veer right and continue to follow signs for I-395 North. Proceed for approximately one mile, then take the exit for US Senate/D Street/I-395 North. Stay in the right lane as you go through two tunnels. In the second tunnel, take the exit for D Street. Make a right turn onto D Street at the stoplight at the end of the tunnel. Go to the second traffic light and turn left onto New Jersey Avenue. The hotel is on the left.

From Points West: Take I-66 East or Route 50 toward Washington to the Theodore Roosevelt Bridge. Exit onto Constitution Avenue. Follow Constitution Avenue toward the U.S. Capitol. A few blocks before the Capitol, make a left onto Louisiana Avenue and proceed for two blocks. Make a left onto New Jersey Avenue. The hotel is one block ahead on the left.

From the Northwest (via I-270): Take I-270 South toward Washington. Keep right to exit onto the I-270 Spur South toward I-495 South in the direction of Washington/Northern Virginia (the I-270 Spur becomes I-495/ Capital Beltway). Take exit 43 to the George Washington Memorial Parkway toward Washington. Follow the GW Parkway until it merges with I-395 North toward Washington. Take the exit for U.S. Senate/D Street/ I-395 North. Stay in the right lane as you go through two tunnels. In the second tunnel, take the D Street exit. Make a right at the light at the end of the tunnel onto D Street. Go to the second traffic light and turn left onto New Jersey Avenue. The hotel is on the left.

**PARKING:** The Hyatt Regency Capitol Hill Hotel offers valet parking to conference attendees at the following hourly rates: less than 1 hour, \$20; 1-2 hours, \$25; 2-10 hours, \$28; and 10-24 hours, \$41. 
