

END USER AGREEMENT

This End User Agreement ("Agreement") is a legally binding contract between you ("End User") and The American Society of Addiction Medicine ("ASAM") regarding the use of certain technology products ("TECHNOLOGY"), which include forms ("FORMS") that incorporate certain copyrighted works ("WORK") owned by The American Society of Addiction Medicine ("ASAM") and/or The Regents of the University of California ("UCLA"), including:

By accessing or using any TECHNOLOGY incorporating the WORK, you acknowledge that you have read, understood, and agree to be bound by the terms of this Agreement. If you do not agree to these terms, you may not use any FORMS or TECHNOLOGY.

1. GRANT OF LICENSE

The license granted under this Agreement is nontransferable, nonexclusive, and intended solely for the End User's internal use as permitted by ASAM under the terms of this Agreement.

2. RESTRICTIONS ON USE

- 2.1. The End User may not use any portion of the FORMS except as expressly allowed under the terms of this Agreement.
- 2.2. The End User is prohibited from creating derivative works based on the WORK, selling, leasing, sublicensing, or otherwise making it available to unauthorized parties.
- 2.3. Any party authorized to use the TECHNOLOGY or FORMS must comply with the provisions of this Agreement.

3. COPYING AND DISCLAIMER REQUIREMENTS

- 3.1. The End User may only download or make copies of the FORMS or TECHNOLOGY content incorporating the WORK if the required DISCLAIMER is included in the same or larger font as the surrounding text.
- 3.2. The copyright in the WORK is owned by ASAM and/or UCLA rights, including trademark and copyright notices, must appear on all backup or archival copies made by the End User.

4. WARRANTY DISCLAIMER AND LIABILITY LIMITATION

To the maximum extent permitted by law:

- 4.1. Each FORM and the content of the WORK in the TECHNOLOGY is provided "as is," without warranties of any kind, whether express or implied.
- 4.2. ASAM and UCLA disclaim all liability, including but not limited to consequential or special damages, lost profits, or errors in data accuracy or completeness.
- 4.3. The End User's sole remedy is for ASAM to use reasonable efforts to correct defects or replace the applicable FORM.
- 4.4. ASAM and UCLA disclaim any liability arising from the use, misuse, or interpretation of the information contained in or omitted from the WORK.

5. INTELLECTUAL PROPERTY RIGHTS

Nothing in this Agreement shall be construed to grant to the End User any ownership or other proprietary interest in the WORK. The End User agrees that they do not acquire any title, ownership, or other intellectual property right or license under this Agreement. The copyright holder(s), ASAM and/or UCLA as specified above, retain all rights in the original and any derivative WORK to the full extent of the law, regardless of whether or not it is used in the TECHNOLOGY. The End User shall not remove, alter, or obscure any copyright, trademark, or other proprietary rights notices incorporated in or accompanying the WORK.

6. INDEMNIFICATION

The End User shall indemnify, defend, and hold harmless ASAM and UCLA from and against all liabilities, damages, losses, claims, actions, demands, fines, penalties, costs, and expenses (including reasonable attorneys' fees) arising from or related to:

- 6.1. The End User's use or misuse of the TECHNOLOGY, FORMS, or WORK.
- 6.2. The End User's violation of any applicable law, rule, or regulation in connection with the use of the TECHNOLOGY, FORMS, or WORK.

THE AMERICAN SOCIETY OF ADDICTION MEDICINE AND UCLA WILL NOT BE LIABLE TO END USER, OR ANY THIRD PARTY FOR LOSS OF PROFITS, LOSS OF USE OR FOR ANY

8. DISCLAIMER OF MEDICAL LIABILITY
